ORDER

As per paper read above as 1 above, the Governing Council of the Kerala State Higher Education Council proposed to restructure the Under Graduate education by introducing Semesterisation and Grading from 2009-2010 academic year onwards. The Council proposed a new pattern of courses for the programme.

The Syndicate, vide paper read as 2nd above considered the proposal of the Kerala State Higher Education Council to restructure UG curriculum - introduction of Choice Based Credit Semester System and Grading at Under Graduate level, and resolved to conduct a workshop for Chairmen, Boards of Studies, Deans of Faculties and representatives of teachers organisation to formulate the modalities to implement the scheme under this University. It was also resolved to constitute an Implementation Committee. The workshop as directed by the Syndicate was conducted on 24th September 2008 and the Implementation Committee was constituted vide paper read as 3 above.

Workshops were conducted by various Boards of Studies under the Faculties of Science, Language and Literature, Humanities, Commerce and Management Studies and Fine Arts for restructuring Syllabi as per directions and financial assistance from the Kerala State Higher Education Council.

As per paper read as 4th above, a Steering Committee for framing modalities for restructuring UG programme was constituted by the Vice-Chancellor with 13 members including a Chairman and one Convenor. The Committee after repeated deliberations in various sittings, formulated a draft regulation for Choice Based Credit Semester System (UG) to be effective from 2009-2010 academic year.

The Boards of Studies under Faculty of Science, Faculty of Language and Literature, Faculty of Humanities, Faculty of Commerce and Management Studies, Faculty of Fine Arts in their meetings held subsequent to workshops resolved to approve the draft regulation of Choice Based Credit Semester System (UG) for 2009-2010 academic year onwards and the syllabi of various UG courses prepared accordingly. The Faculties of Fine Arts, Science, Humanities, Language and Literature, Commerce and Management Studies vide paper 5 above approved the draft regulation for Choice Based Credit Semester System (UG) to be effective from 2009-2010 academic year onwards.

Vide paper read as 6 above, the Syndicate resolved to approve the draft regulation for Choice Based Credit Semester System programme for UG curriculum from 2009 admission onwards and to place the same before the Academic Council.

The Academic Council vide paper read as 7 above approved the draft regulations of the Choice Based Credit Semester System programme for UG Curriculum for implementing the same from 2009 admission onwards incorporating the modifications.

Sanction has therefore been accorded for implementing the draft regulation of Choice Based Credit Semester System for UG curriculum from 2009 admission onwards in the affiliated colleges.

Orders are issued accordingly. Regulation for Choice Based Credit Semester System (UG) is appended.
